

BEGINNENG at an iron pin on the northern edge of a five (5) foot sidewalk running along said Perry Road, said pin being the joint front corner of lots number five (5) and six (6), and running thence along the eastern line of lot five (5), N. 47 - 0 W., one hundred and thirty one (131) feet to an iron pin, joint rear corner of said lots five and six; thence along the rear line of lot twenty-three (23), N. 43-0 E., sixty (60) feet, to an iron pin, joint rear corner of lots six (6) and seven (7); thence along the western line of lot 7 seven S. 47 - 0 E. one hundred and thiry one (131) f et to an iron pin on the norther edge of said sidewalk running along the Perry Road, said pin being the joint front corner of lots six (6) and seven (7); thence along the northern edge of said sidewalk, S. 43-0 W., sixty (60) feet to an iron pin, the beginning corner, said lct being known and designated as lot numbered six (6) on Plat of said Property recorded in the Office of the Register of Hesne Conveyance for Greenville County in Book "Q" at page 25, which plat is hereby referred to and made a part hereof.
