ville, South Carolina, being known and designated as Lot #176 and the Westerly and
adjoining one-half ($\frac{1}{2}$) of Lot #175, Cleveland Forest, according to Plat of said
sub-division prepared by Dalton & Neves, Engineers, May, 1940 as revised September,
1945, as recorded in the R.M.C. Office, County of Greenville, South Carolina, in
Plat Book "M" on page 137, and having according to said Plat, the following metes
and bounds, to wit:Beginning at an iron pin on the North side of Knollwood Lane at joint front corner
