


their Heirs and Assigns:

all that piece, parcel or lot of land in Greenville Township, Greenville

County, State of South Carolina, situate, lying and being on the so called side  
of Phillips Lane near the City of Greenville, being said lots 10 and  
11 and a 5 ft. strip on the southwest side of lot 9 c. flat  
of property of Mr. Huguenin and John W. Phillips, revised by Haskell  
Maitlin, architect, November 20, 1943, recorded in the ... C. Office  
for Greenville County, S.C. in Plat Book "A", page 200, is having  
according to said plat the following corner and bounds, to-wit:

BEGGING at an iron pin or the Southeast corner of Phillips  
Lane, said pin being 9' 1.4 feet in a southwesterly direction from the  
point where the Southeast line of Phillips Lane intersects the  
southwest side of Augusta road and 60 feet from the front  
front corner of lots 9 and 10 in running westwardly along the parallel  
with the joint line of lots 9 and 10 4'-4" to 4'-4" 1/2 feet; thence  
along the line of the beginning property 5'-11" 1/2 feet to an  
iron pin, joint rear corner of lots 10 and 11; thence west, the line  
of lots 10 and 11 4'-4" 1/2 feet to the joint front corner of  
lots 10 and 11; thence along the line of Phillips Lane 4'-4" 1/2  
feet to the beginning corner, said point being 1 foot from the  
joint front corner of lots 9 and 10, the joint corner  
being also on lot 10 and a 5 ft. strip on the southwest side of  
lot 9.
