

State of South Carolina lying and being on the Northeast side of Westview Avenue, near the City of Greenville, in the county of Greenville, State of South Carolina being known and designated as lot number eleven (11) of block "G" in section four (4) on plat of East Highlands made by Dalton and Neves, engineers, January 1941 recorded in the RCM office of Greenville, S.C. in plat book "K" at page 78,79, and 80 and having according to said plat the following metes and bounds to wit: Beginning at an iron pin on the Northwest side of West view avenue at joint front corner of lots ten (10) andeleven (11) of block "G" and running thence with the Northwest side of Westview Avenue, S.37-O W. 43 feet to an iron pin; thence continuing with Westview Avenue along a curve line to an iron pin on the North side of Sunset Drive (the chord of which is S. 80-47 W 36.1 feet) thence with the North side of Sunset Drive N.55-25 W 192.3 feet to an iron pin; thence along the Southeast side of a ten (10) foot strip reserved for utilities, N. 34-13 E. 77.2 feet to an iron pin at corner of lot seven (7) thence with line of lots seven (7) and ten (10), S. 53-O E.220.7 feet to an iron pin on the Northwest side of Westview Avenue, the beginning corner. This property is conveyed subject to the restrictive covenants and building restrictions which are fully set forth in an instrument dated Feb. 26, 1941 and recorded in the RMC office for Greenville county, State of South Carolina in deed book, vol. 231 at page 1.
