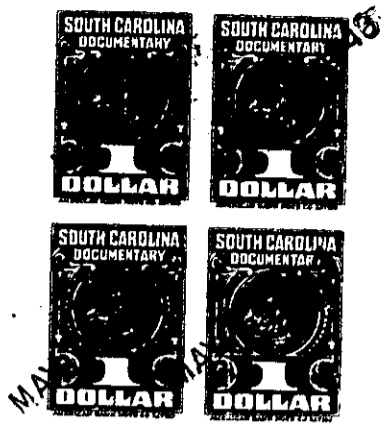

County, State of South Carolina, known and designated as Lots Nos. 6 and 8, Block L, in sub-division known as Fair Heights as shown on plat recorded in R. M. C. Office for Greenville County in plat book F, page 257, said lots fronting on Cumberland Avenue, and described as follows:

Lot No. 6: Beginning at a point on the western side of Cumberland Avenue at the joint front corner of lots 5 and 6 and running thence along the line of lot 5, N. 58-40 W. 140 feet to a point at the joint corner of lots 5, 6, 17 and 18; thence along the rear line of lot 17, S. 31-20 W. 50 feet to a point at the joint rear corner of lots 6, 7, 16 and 17; thence along the line of lot 7, S. 58-40 E. 140 feet to point on the western side of Cumberland Avenue; thence along the western side of Cumberland Avenue N. 31-20 E. 50 feet to beginning corner.

Lot No. 8: Beginning at the joint front corner of lots 7 and 8 on the western side of Cumberland Avenue, thence along the line of lot 7, N. 58-40 W. 140 feet to a point at the joint rear corner of lots 7, 8, 15 and 16; thence along the rear line of lot 15, S. 31-20 W. 50 feet to a point at the joint rear corner of lots 8, 9, 14 and 15; thence along the line of lot 9, S. 58-40 E. 140 feet to a point on the western side of Cumberland Avenue; thence along the western side of Cumberland Avenue N. 31-20 E. 50 feet to the beginning corner.

ALSO: All those pieces, parcels or lots of land in Butler Township, Greenville County, State of South Carolina, being known as Lots Nos. 16 and 17, Block L, according to plat of property of Fair Heights, plat recorded in Plat Book F, Page 257 on record in R. M. C. Office for Greenville County, S. C., and having according to said plat the following metes and bounds, to-wit:
Beginning at a point on the east side of Fairview Avenue, joint front corner of Lots 15 and 16, and running thence along the dividing line of said lots S. 58-40 E. 142.3 feet to a point; thence along the rear lines of Lots 7 and 6, N. 31-20 E. 100 feet to a point; thence along the dividing line of Lots 17 and 18, N. 58-40 W. 141.5 feet to a point on the east side of Fairview Avenue; thence along the east side of Fairview Avenue S. 31-47 W. 100 feet to the point of the beginning.

ALSO: All that certain piece, parcel or lot of land in Butler Township, County and State aforesaid, being known as Lot No. 19 of Block L according to plat of Fair Heights, plat recorded in Plat Book F, Page 257 on record in R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
