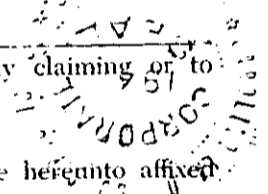
all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as:
