All those certain pieces, parcels or lots of land situate, lying and being on the Southeast side of Simmons Avenue near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as all of Lot 2 and part of Lots 1 and 3 on plat of Property of Daisy T. Wilson made by Dalton & Neves, Engineers, June 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "O", page 151, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the front line of Lot 3, said pin being 222.5 feet in a Southwesterly direction from the point where the Southeast side of Simmons Avenue intersects with the Southwest side of Sycamore Drive and running thence through Lot 3, S. 62-11 E. 180 feet to an iron pin in the rear line of Lot 3; thence S. 21-30 W. 101 feet to an iron pin in the rear line of Lot 1; thence through Lot 1 in a straight line and in a Northwesterly direction 180.5 feet, more or less, to an iron pin in the front line of Lot 1, said pin being 308.5 feet in a Southwesterly direction from the point where the Southeast side of Simmons Avenue intersects with the Southwest side of Sycamore Drive; thence along the Southeast side of Simmons Avenue, N. 21-30 E. 86 feet to the beginning corner.
