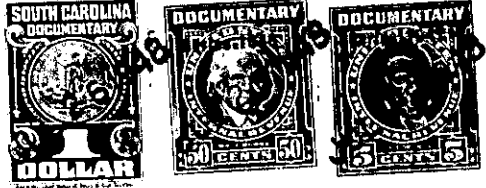

northeast side of the Greenville-Woodruff Road and on the west side  
of the road that leads from said road to Batesville, being tri-  
angular in shape and being a part of lot No. 6 as shown on Plat  
of Property of L. I. Green Estate, original plat prepared by W. A.  
Christopher, Surveyor, September 1921, and revised by R. E. Dalton,  
Enginer, 1922, and having the following courses and distances,
