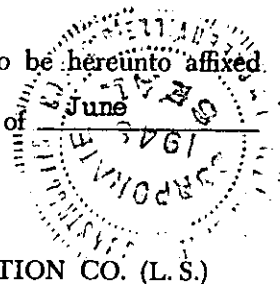
This deed is further subject to utility easements of record.
