

Beginning at a point on the Buncombe Road, joint corner of Lots Nos. 8 and 9, and running thence in a westerly direction one hundred and eighty-three (183) feet to a pin on an alley, joint rear corner of lots No. 8 and 9, thence in a southerly direction along said alley forty-five (45) feet to a point at the joint rear corner of lots Nos. 7 and 8; thence in a eastern direction along the dividing line between said lots Nos. 7 and 8, one hundred and eighty-seven (187) feet to a pin on the Buncombe road, joint fromt corner of lots Nos. 7 and 8; thence along the Buncombe Road in a northerly direction sixty (60) feet to the beginning corner; being one of the lots conveyed to R.L.
