I, E. INMAN, Master in and for the County aforesaid, SEND GREETING:

WHEREAS, R. A. Riddle, Administrator of the Estate of J. M. Riddle,
deceased, and Individually, et al,

on or about the 27th day of September in the year of
our Lord nineteen hundred and forty-eight exhibited their
complaint in the Court of Common Pleas, for the County aforesaid, against
Eliza C. Riddle, et al,

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to
be heard on the 7th day of December 1948,
and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged

for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear;

NOW, Therefore, Know all Men by these Presents, that I, E. INMAN, Master, in and for the County
of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$4500.00

HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release
unto the said W. M. Riddle

"All that certain tract of land in Grove Township, said Green-
ville County, State of South Carolina, about nine miles from Green-
ville Court House being known and designated as Tract No. 2, ac-
cording to the survey of J. M. Riddle estate lands made by W. J.
Riddle, June, 1948, and having the following metes and bounds:

BEGINNING in a road at the corner of Tract No. 1 on the Ash-
more line; thence with the Ashmore line N. 59-30 E. 836 feet to a
pin; thence N. 71-30 E. with W. M. Riddle line 1052 feet to a pin
Riddle and Johnson corner; thence with Johnson line N. 18-30 W.
357 feet to a pin; thence crossing a branch N. 75-25 E. 970 feet to a
pin J. D. Charles estate and Johnson corner; thence with the Charles
line N. 37-30 W. 946.6 feet to pin thence S. 55 W. 667.8 feet to a
stone E. B. Hendrix corner; thence with Hendrix line S. 44-30 W. 804
feet to stone; thence crossing a branch N. 63-30 W. 618 feet to a
stone W. H. Willimon's corner; thence with Willimon line S. 17-42 W.
