PARTIAL RELEASE OF JUDGMENT LIEN

Whereas by Order dated Sept. 20, 1940 the undersigned, G. M. Cooper, obtained a judgment against Mrs. Essie Waters in the sum of \$1,000.00, with interest at the rate of seven per cent. per annum from April 18, 1938, together with 10 per cent. attorney's fee and court cost, which judgment is enrolled in Judgment Roll no. E 8516 in the Clerk of Court's office for Greenville County, South Carolina; and

Whereas the undersigned now desires to release the below described property from the lien of said judgment; NOW

KNOW ALL MEN BY THESE PRESENTS, that for value received, the undersigned G. M. Cooper does hereby release and forever discharge from the lien of the said above mentioned judgment the property hereinafter described, to-wit:

All that piece, parcel or lot of land lying, being and situate at or near Five Forks, in Butler Township, County and State aforesaid, on the Northeast side of the Greenville-Woodruff Road and on the West side of the road that leads from said road to Batesville, being triangular in shape and being a part of lot no. 6 as shown on plat of property of I. L. Green Estate, original plat prepared by W. A. Christopher, Surveyor, Sept. 1921, and revised by R. E. Dalton, Engineer, 1922, and having the following course and distances, to wit: Beginning on a nail and stopper in the center of said Greenville-Woodruff Road at the center of the intersection of the Batesville Road, and runs thence with said Greenville-Woodruff Road N.48-30 W.374 feet to a nail and stopper in the center of the said last mentioned road, thence a new line N.63-06 E.250.5 feet to a nail and stopper in the said Batesville Road (iron pin on eastern bank of Greenville-Woodruff Road at 26 feet., and iron pin on the West bank of the Batesville Road at 20.7 feet.), <sup>thence</sup> with the Batesville Road S.9-00 E.366 feet to the beginning corner, and containing One (1) acre, more or less. The above described lot is the same property described in deed of Thomas Waters, Jr. to B. T. Westmoreland by deed recorded in the R. M. C. Office for said County in Deed Book 354, page 189. Also see deed of Essie Waters Cooper to B. T. Westmoreland recorded in said office in Deed Book 358, page 479.

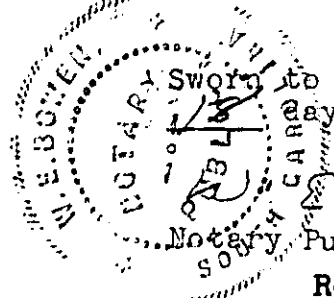
