

All that piece, parcel or lot of land in Fairview Township, Greenville County, State of South Carolina, with the buildings and improvements thereon situate, lying and being on the East side of Craig Street, in the town of Fountain Inn, County of Greenville, State of South Carolina, being shown as Lot #1 on Plat of property of George P. Wenck, made by E. E. Gary, Surveyor, June 21, 1946, and having, according to said plat, the following metes and bounds, to wit:

Beginning at an iron pin on the East side of Craig Street at joint front corner of Lots 1 and 2, said pin being 2.34 chains north from the corner of J. H. Nolson land on Craig Street and running thence with the line of Lot 2, S. 77-45 E. 6.33 chains to an iron pin; thence N. 4-00 E. 85 links to an iron pin; thence N. 75-00 W. 6.40 chains to an iron pin on the east side of Craig Street; thence with the east side of Craig Street, S. 2-30 W. 1.17 chains to the beginning corner.
