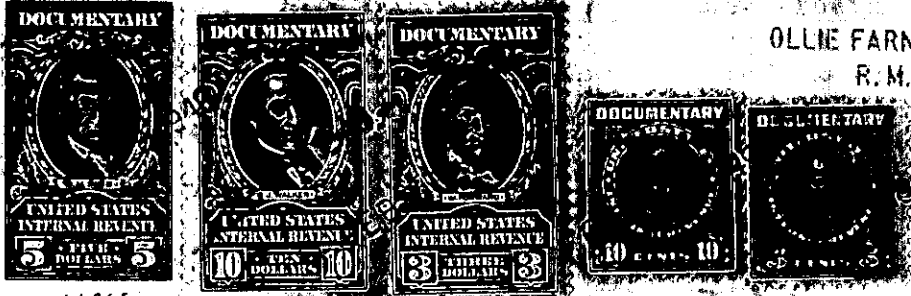

TYCHO N. NISSEN

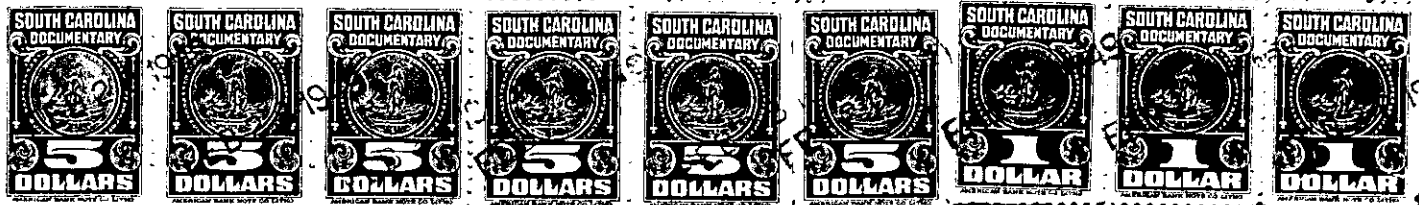
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these pres-
ents do grant, bargain, sell and release unto the said TYCHO N. NISSEN, His Heirs and
Assigns, Forever:

All that certain piece, parcel or lot of land situate,
lying and being on the North side of Tallulah Drive in the City
of Greenville, County of Greenville, State of South Carolina,
being a portion of Lot No. 117 as shown on a plat of the estate
of D. T. Smith prepared in May, 1935, by Dalton & Neves, Engi-
neers, and recorded in the R. M. C. Office for Greenville County,
S. C., in Plat Book H, at page 279, and having, according to said
plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Tallulah
Drive at the joint corner of Lots No. 116 and 117, and running
thence along the common line of said lots, N. 25-20 W. 242.8 feet
to an iron pin; thence N. 65-26 E. 70 feet to an iron pin; thence
S. 25-20 E. 241.8 feet to an iron pin on Tallulah Drive; thence
with the North side of Tallulah Drive, S. 64-40 W. 70 feet to an
iron pin, the beginning corner.

The above described property was conveyed to the grantor
herein by two separate deeds, to-wit:- Deed of Nina Jones Duncan
to Eva Coffey Williams dated October 18, 1944, and recorded in the
R. M. C. Office for Greenville County, S. C., in Deed Vol. 268,
at page 421, and deed of Lewis W. Haselwood to Eva Coffey Williams
dated December 17, 1940, and recorded in the R. M. C. Office for
Greenville County, S. C., in Deed Vol. 265, at page 126. The
above described property is composed of all the property con-
veyed by Nina Jones Duncan and a portion of the property con-
veyed by Lewis W. Haselwood.

The grantee herein assumes and agrees to pay all 1949
City, State and County taxes on the above described property.
