All that piece, parcel or lot of land in Oaklawn Township, Greenville County, State of South Carolina, as shown on the plat of the Katrine Manufacturing Company's property and described by metes and bounds, as follows:

BEGINNING in the center of the Fork Shoals Road on the North line of Katrine Manufacturing Company's property and running S. $62\frac{1}{2}$ E., 4.6 chs. to a stake on the river; thence with the said river S. E. 1.0 chs. to a stake; thence N. $62\frac{1}{2}$ W. 4.6 chs. to the center of Fork Shoals Road; thence with said road N-E. 1.0 ch. to the beginning corner and containing .46 acres, more or less. Being the same lot of land conveyed to J. B. Riddle by Katrine Manufacturing Company by deed dated April 25, 1917 and recorded in R.M.C. Office for Greenville County in Volume 25 at at page 366.

ALSO: All that piece, parcel of land being in County and State aforesaid, lying on the West side of Reedy River, and having the following metes and bounds: COMMENCING on Iron Wood on bank of said river; thence N. $64\text{-}\frac{3}{4}$ W., 5.30 to stone on Fork Shoals Road; thence S. $64\text{-}\frac{3}{4}$ E. 8.11 to stone on river; thence down said river 8.65 to beginning corner, containing 6.2 acres, more or less. Being the same tract of land conveyed to J. B. Riddle by W. P. Rogers by deed dated Feb. 2, 1910 and recorded in the R.M.C. Office for Greenville County in Volume 8 at page 277.

ALSO: All that piece or parcel of land lying and being in the State aforesaid, and County of Greenville, on Reedy River, beginning on a stone on bank of said river and thence N. $64\text{-}\frac{3}{4}$ E. 4.50 to a stone on Road; thence up Road N. 28 E. 8.15 to stone; thence S. $64\text{-}\frac{3}{4}$ E. 5.30 to Iron Wood on bank of river; thence down river 8.20 to the beginning corner, and containing 4 acres, more or less, and bounded by lands of G. W. Sullivan, Fork Shoals Cotton Mills Company, and others, and being the same tract of land conveyed by J. B. Riddle to Josephine Riddle, by deed dated January 23, 1908 and recorded in the R.M.C. Office for Greenville County in Deed Book 157 at page 566.
