RATIFICATION AGREEMENT

County OF GREENVILLE } KNOW ALL MEN BY THESE PRESENTS:

THAT THE UNDERSIGNED, for and in consideration of the sum of _____ Dollars (\$ 1.00) cash in hand paid by TRANSCONTINENTAL GAS PIPE LINE CORPORATION, the receipt of which is hereby acknowledged, do _____ by these presents accept, adopt, ratify and confirm unto TRANSCONTINENTAL GAS PIPE LINE CORPORATION, its successors and assigns, that certain Right of Way Agreement executed by _____

dated May 16, 1949, covering certain lands situated in _____ County, State of South Carolina, described as follows:

Containing 141.30 acres and being Tracts Nos. 6 and 7 of Gray-Ramsome Farm, and being the following courses and distances according to a plat by J. O. Little, Surveyor, March, 1903: BEGINNING at a stone, Stoddard's corner, thence N 20° 30' E 300 feet; thence N 45-06 E 1710 feet; thence S 73-40 E 2014 feet to a stake in center of road; thence with said road in the following courses; S 11 W 515 feet; S 27-30 W 780 feet; S 18 W 160 feet; S 8 W 1158 feet; S 9 W 720 feet; S 16-20 W 518 feet; S 24-45 W 437 feet; S 17 W 439 feet; thence leaving road N 79-15 W 271 feet; thence N 2 W 2807 feet; thence N 80 W 1749 feet to the beginning. Bounded on the North by R. O. Coker, on the East by a road which separates the lands herein described from the lands of R. O. Coker, and Tracts 3, 4, and 5 of the Gray Ramsome Farm; on the South by Joseph lands and on the West by Joseph, Stoddard and King Lands. LESS 38 acres conveyed to Hazel Coker by Deed recorded Vol. 197 at page 318 and 52.30 acres conveyed to Harold Coker by deed recorded in Vol. 207 at page 292. Being all or part of the land described in Will of R. O. Coker, dated 5/13/36, recorded in Book 515, page 28, records of Greenville County, South Carolina.

Also, All that tract on Little Reedy Fork containing 123 acres bounded by lands of Samuel Tembling, Mrs. Mary Gray, Sam McDavid, Estate of C. P. Berry and W. H. Rabb.

Also, All that tract situated in the state and county aforesaid containing 95 acres, more or less and adjoining lands of Robert Coker, Mrs. Mary Gray and L. Berry.
