Know All Men by These Presents:

That I, David G. Traxler, in the State aforesaid, in consideration of the sum of Seven Hundred and No/100 (\$700.00) ----- DOLLARS, and assumption of mortgage hereinbelow referred to to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said RALPH S. COX, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #273, Pleasant Valley, according to plat of said sub-division prepared by Dalton & Neves in April, 1946, including additions to said Plat through November, 1948, as recorded in the R.M.C. Office for Greenville County, in Plat Book "P", at Page 92, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Prancer Avenue at joint front corner of Lots #272 and #273, said pin being 420 feet Northeast of iron pin in the Northeast corner of the intersection of Prancer Avenue with Panama Avenue; thence N. 0-08 W. 160 feet to an iron pin at joint rear corner of Lots #272 and #273; thence S. 89-52 W. 60 feet to an iron pin at joint rear corner of Lots #273 and #274; thence S. 0-08 E. 160 feet to an iron pin at joint front corner of Lots #273 and #274 on the Northern side of Prancer Avenue; thence along said Avenue N. 89-52 E. 60 feet to iron pin at joint front corner of Lots #272 and #273, the point of beginning.

The herein named grantee is to pay the 1949 taxes on the above described property. The above described property is subject to restrictions recorded in the RMC Office for Greenville County, S.C., in Deeds Volume 301, at Page 60.

As a part of the consideration hereof, the herein named grantee assumes and agrees to pay, according to its terms, that certain note and mortgage dated June 9, 1949, given by David G. 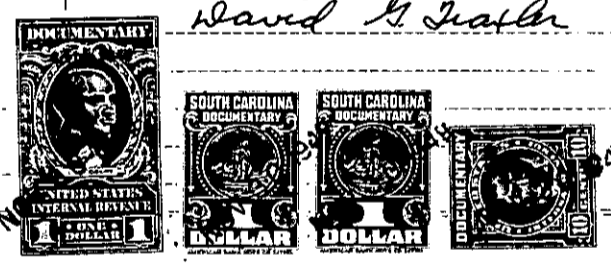
