All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, Greenville County, State of South Carolina, on the Northern side of Hillcrest Drive, and being known and designated as Lot No. 5 and the Western one-half of Lot No. 6 of Block D, according to plat of Highland Terrace, recorded in the R. M. C. Office for Greenville County in Plat Book D, at page 238, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Hillcrest Drive at the joint front corner of Lots Nos. 4 and 5, Block D, and running thence along the common line of said lots, N. 22-57 E. 190 feet to an iron pin at the joint rear corner of said lots; thence S. 67-03 E. 105 feet to a stake in the center of the rear line of Lot No. 6 of Block D; thence through the center of said Lot No. 6, S. 22-57 W. 190 feet to a stake on the Northern side of Hillcrest Drive in the center of the front line of said Lot No. 6; thence along the Northern side of Hillcrest Drive N. 67-03 W. 105 feet to an iron pin, the beginning corner.
