That I, David G. Traxler, in the State aforesaid, in consideration of the sum of Six Thousand Sixty and No/100 (\$6,060.00) ----- DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Cecil L. Hendrix, his heirs and assigns all that piece, parcel or lot of land in Greenville Township, County of Greenville, State of South Carolina, lying and being situate on the Northern side of Prancer Avenue, within the limits of the City of Greenville, South Carolina, being known and designated as Lot #263, Pleasant Valley, according to plat of said Subdivision prepared by Dalton & Neves in April, 1946, including additions to said Plat through November, 1948, as recorded in the R.M.C. Office, Greenville, South Carolina, in Plat Book "P", at Page 92, and having, according to said Plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of Prancer Avenue at joint front corner of Lots #263 and #264, said pin being 960 feet Northeast of iron pin in the Northeast corner of the intersection of Prancer Avenue with Panama Avenue; thence N. 0-08 W. 160 feet to an iron pin at joint rear corner of Lots #263 and #264; thence N. 89-52 E. 60 feet to an iron pin at joint rear corner of Lots #262 and #263; thence S. 0-08 E. 160 feet to an iron pin at joint front corner of Lots #262 and #263, on the Northern side of Prancer Avenue; thence along said Avenue, S. 89-52 W. 60 feet to an iron pin at joint front corner of Lots #263 and #264, the point of beginning.

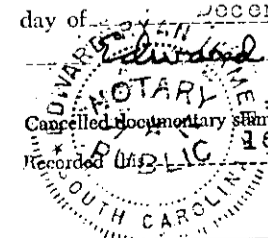
RENUNCIATION OF DOWER I, Edward Ryan Hamer Notary Public, do hereby certify
