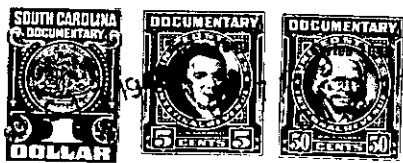
Know All Men by These Presents:

M. C. Office for Greenville County in Plat Book U, at page 155 and said lot having, according to the plat, the following metes and bounds, to-wit:
