to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ray T. Whitaker, his heirs and assigns:

All that certain, piece, parcel or lot of land with the buildings and improvements thereon lying and being on the Southerly side of Alabama Avenue, Near the City of Greenville, S. C., being shown as lot #102 plat of the property of Talmer Cordell recorded in the RMC Office for Greenville County, S. C. in Plat Book "V", page 198, and having according to said plat the following metes and bounds to-wit: BEGINNING at an iron pin on the Southerly side of Alabama Avenue at a point 124 feet West of the South-west corner of the intersection of Alabama Avenue and Texas Avenue, joint front corner of lots 101 and 102 and thence along the line of lot #101 S 29-17 W 200 feet to an iron pin; thence N 60-43 W 61 feet to an iron pin, joint rear corner of lots 102 and 103; thence N 29-17 E 200 feet to an iron pin on the Southerly side of Alabama Avenue; thence along the Southerly side of Alabama Avenue S 60-43 E 61 feet to the point of beginning.
