McCormick and Ann J. McCormick their heirs and assigns, forever:

All that certain piece, parcelor lot of land situate, lying and being on the East side of the Whitehorse Road, Gantt Township, Greenville County, South Carolina, being shown as Lot No. 1 on Plat of property of O. T. White prepared by W. J. Riddle in 1948 and having the following metes and bounds

PEGINNING at an iron pin on the East side of the Whitehorse Road at corner of property now or formerly Lois McAdams; thence along the line of said property N. 64-35 E. 330 feet to an iron pin; thence N. 56-20 W. 76 feet to an iron pin at corner of Lot No. 2; thence with the line of Lot No. 2 S. 64-35 W. 303 feet to an iron pin on the East side of the Whitehorse Road; thence with the East side of the Whitehorse Road as the line S. 34-50 E. 65 feet to point of beginning.
