S. Moore by H.S. Brockman, Surveyor, dated April 24,1944, recorded in the R.M.C.Office for Greenville County, having the following courses and distances: BEGINNING on a stake on the western edge of Morrow Street, joint corner of lots Nos. 6 and 7, and runs thence with said street S. 32.41 W. 100 feet to a stake, joint corner of lots Nos. 5 and 6; thence N. 66.24 W. 165.5 feet to a stake; thence N. 34.56 E. 100 feet to a stake; thence S. 66.39 E. 161.6 feet to

Third: No house shall be built on this property costing less than \$5,000.00.

The above conditions and restrictions shall remain in full force and effect

for a period of thirty (30) years from the date of this deed.
