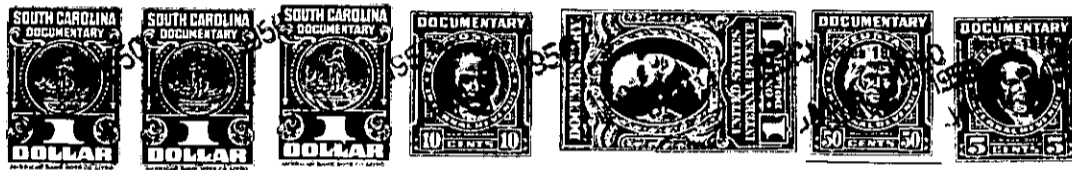
Know All Men by These Presents:

Kirkland and Doris Mullinnix Kirkland, in the State aforesaid, in consideration of the sum of Fifteen Hundred and No/100 (\$1500.00) and assumption of mortgage set out below to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said F. D. Brosnan and Hattie D. Brosnan, their Heirs and Assigns forever,

All that lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as a portion of lot No. 46 as shown on plat of property of the Estate of D. W. Cochran, recorded in Plat Book I, at Pages 91 and 92, and being more particularly described according to said plat, and also according to a recent survey of said property made by The McPherson Company, October 25, 1946, as follows:

BEGINNING at an iron pin on the East side of Oak View Drive, which pin is 221.5 feet from the intersection of said Oak View Drive and Augusta Drive East, and running thence S. 52-04 E. 136 feet to iron pin; thence S. 37-56 W. 10 feet to iron pin; thence S. 52-04 E. 25-feet to iron pin; thence S. 37-56 W. 60 feet to a stake; thence N. 52-21 W. 141.1 feet to iron pin on the east side of said Oak View Drive; thence with said Oak View Drive, N. 21-56 E. 73.04 feet to the beginning corner. Being the same premises conveyed to the grantors by John T. Loftis by deed recorded in Volume 380 at Page 99.

As a part of the consideration for this deed, the grantee assumes and agrees to pay a balance of \$5769.28 due on a mortgage executed by John T. Loftis to Aiken Loan & Security Company recorded in Book of Mortgages 355 at Page 90.
