WHEREAS on July 22nd 1896, J. D. Norman prepared a plat of property of Robert and Thursa Gibson, deceased, and on said plat shows a small lot of 1/2 acre, more or less, lying on the east side of the old Reid

School Road and designated same as lot "C" on said plat, and WHEREAS it has always been understood that the said OLD ROAD was the line between the property lying on the east side of the said 1/2 acre lot, and WHEREAS my deed covers the said lot "C", and now to clear the records, making the said OLD ROAD the line I, Belle Martin Sammons, now execute this deed for the said purpose, NOW THEREFORE

KNOW ALL MEN BY THESE PRESENTS, That I, Belle Martin Sammons,

in the State aforesaid, in consideration of the sum of one dollar

to me in hand paid at and before the sealing of these presents  
by Lurennia Alexander

(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Lurennia Alexander, her Heirs...

and Assigns forever ALL of my right, title and interest in and to

all that piece, parcel or lot of land in Chick Springs Township, Greenville

County, State of South Carolina, located about one mile north from Taylors, lying on the east side of the Old Road leading from Taylors to Reid's School and east from the present Reid School Road, being bounded on the east by lands of Lurennia Alexander, on the south by lands formerly of Boyce Bridwell (now of Doc. McPherson) and on the west by the said old road and lands of myself, and being a part of the same land that was conveyed to me by deed recorded in the office of the R. M. C. for Greenville County in Deed Book 193 at page 116, and having the following courses and distances, to wit:-

Beginning on a stone at graveyard, joint corner of other lands of myself and of Southern and of Lurennia Alexander, and runs thence with the Alexander line S. 31-30 E. 552 feet. to a pine on the Mc Pherson line; thence with the said line S. 57-00 W. 55 feet#, to a stone on the east side of the said Reid School Road; thence with the said Old Reid School Road N. 25-45 W. 557 feet. to the beginning corner, and containing one half (1/2) acre, more or less.
