to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said R. V. Chandler, Jr., his heirs and assigns forever:

All that piece, parcel or lot of land in Greenville County, State of South Carolina, in the City of Greenville, and being known and designated as lot No. 11 and one-half of lot No. 12 as shown on Plat of Nicholtown No. 4, prepared by W. J. Riddle November 3, 1943, recorded in Plat Book N, at Page 139, and being more particularly described as follows:

BEGINNING at an iron pin on the Southwest side of Horney Street, joint corner of lots Nos. 10 and 11, and running thence S. 53-43 W. 142.2 feet to an iron pin; thence N. 29-04 W. 60.3 feet to a point in the center of the rear line of lot No. 12, and running thence through the center of lot No. 12, N. 53-43 E. 134.7 feet more or less to a point on Horney Street in the center of lot No. 12; thence along Horney Street, S. 36-17 E. 60 feet to the point of beginning.
