to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Cecil E. Watkins, his heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the East side of North Main Street, near the City of Greenville, in the County of Greenville, State of South Carolina, being shown as Lot 7 of Block "C" on Plat of property of J. A. and P. F. Cureton, known as Northgate, made by Dalton & Neves, Engineers, February, 1942, recorded in the R.M.C. Office for Greenville County, S.C. in Plat Book "K", at Page 113, and having according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of North Main Street at joint front corner of Lots 6 and 7 of Block "C" and running thence with the line of Lot 6 Due East 184.2 feet to a stake in the rear line of Lot 21; thence along the rear line of Lots 21 and 22 N 7-16 W 75.5 feet to an iron pin; thence with the line of Lot 8 Due West 174.3 feet to an iron pin on the East side of North Main Street; thence with the East side of North Main Street Due South 75 feet to the beginning corner.
