

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Everett B. Waldrop and Annie T. Waldrop, their heirs and assigns, forever;

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate and being on the Southeast side of Easley Bridge Road, near the City of Greenville, Greenville County, S. C., shown as Lot #16, Map #2 of Camilla Park, made by W. J. Riddle, Surveyor, under date of December, 1943, and recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book "M", page 85, and having, according to said plat, the following metes and bounds, towit:

BEGINNING at an iron pin on the Southeast side of Easley Bridge Road, joint front corner of Lots 15 and 16, said pin being 480 feet in a Southwesterly direction from the point where the Southeast side of Easley Bridge Road intersects with the Southwest side of Harvard Avenue, and running thence with the line of Lot 15 S 60-51 E 215.2 feet to an iron pin; thence S 27-40 W 80.7 feet to an iron pin; thence along the line of Lot 17 N 60-51 W 217.8 feet to an iron pin on the Southeast side of Easley Bridge Road; thence along the Southeast side of Easley Bridge Road N 29-09 E 80 feet to the beginning corner.

As a part of the consideration of this conveyance, the grantees assume and agree to pay the balance due on that mortgage given by Robert F.
