****DECREE OF DIVORCE****

At a Session of said Court convened and held at the Courthouse in the City of Detroit, said County and State on the Twenty-third (23rd) day of May, A.D. 1930.

PRESENT: The Honorable ALLAN CAMPBELL Circuit Judge.

This cause having come on to be heard upon the Cross-Bill of Complaint filed herein, taken as confessed by the cross-Defendant for want of an Answer, and upon pleadings and proofs had thereon taken in open Court from which it satisfactorily appears to this Court that the material facts charged in such Bill of Complaint are true, and that the cross-Defendant, Vera K. Coleman, has been guilty of the several acts of extreme and repeated cruelty therein charged, on Motion of George A. Lumsden, the Attorney of record for the said James H. Coleman, cross-Plaintiff,

IT IS ORDERED, ADJUDGED AND DECREED, and this Court by virtue of the authority therein vested, and in pursuance of the Statute in such case made and provided,

DOTH ORDER, ADJUDGE AND DECREE that the marriage between the said Cross-Plaintiff, James H. Coleman and the said Cross-Defendant, Vera K. Coleman, be dissolved, and the same is hereby dissolved accordingly, and a divorce from the bonds of matrimony between the parties is Adjudged and Decreed.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the above-named Cross-Plaintiff, James H. Coleman, be awarded the care, custody and control of Herman Coleman, aged four, and James Martin Coleman, aged eighteen months, minor children of the parties hereto, until they shall have respectively attained the age of sixteen years.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Cross-Defendant, Vera K. Coleman, have the right and privilege of visiting with, and the temporary custody for brief intervals of time of the aforesaid minor children of the parties hereto, but the said Cross-Defendant, Vera K. Coleman, shall not remove the aforesaid minor children from the control, care and custody of the Cross-Plaintiff, James H. Coleman, over extended periods except with the express consent of the said Cross-Plaintiff.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Cross-Defendant, Vera K. Coleman, in consideration of the sum of One (\$1.00) Dollar paid by the said Cross-Plaintiff to the said Cross-Defendant, is hereby barred from all right of dower which she might have in the real estate owned by the said Cross-Plaintiff, or which he might hereafter acquire.
