That Talmer Cordell in consideration of the sum of Thirty - Three Hundred and no/100 (\$3,300.00) in the State aforesaid, DOLLARS,

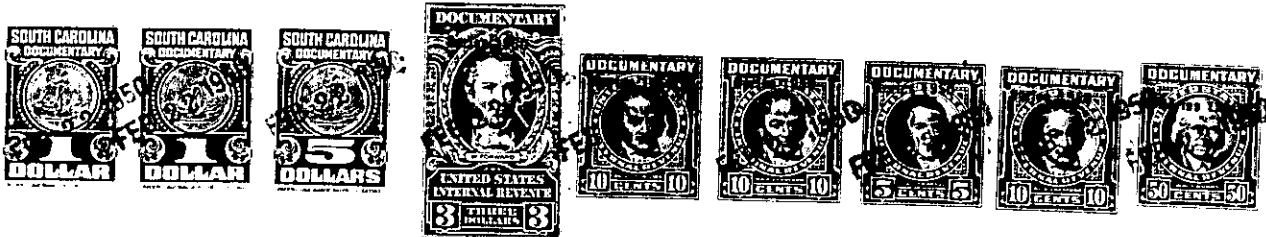

All that certain, piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Southwesterly side of Alabama Avenue, near the City of Greenville, S. C., being shown as lot #107 on the Plat of the Talmer Cordell Subdivision recorded in the R.M.C. Office for Greenville County, S. C., in plat book "V", page 198, said lot having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Southwest side of Alabama Avenue at a point 429 feet Northwest of the Southwest corner of the intersection of Alabama Avenue and Texas Avenue, joint front corner of lots 107 and 107; and thence along the Southwesterly side of Alabama Avenue N 60-43 E 61 feet to an iron pin; thence S 29-17 W 200 feet to an iron pin; thence S 60-43 W 61 feet to an iron pin; joint rear corner of lots 106 and 107; thence along the joint line of lot 106 and 107 N 29-17 E 200 feet to the point of beginning.
