one mile southwest from the corporate limits of Greer, lying south from the Brushy  
Creek Road and on the East of a new street that leads therefrom, being all of  
lot #24 on plat of the S. H. James Estate, by H. L. Dunahoo, recorded in Plat  
Book T, page 12, and having the following courses and distances, to-wit:-
