All that certain lot of land in Greenville County, South Carolina, on the Northern side of Carey Street, formerly East Croft Street, in the City of Greenville, being known and designated as Lot No. 3 on the Plat of D. R. Cain, Trustee, recorded in Plat Book H at Page 135, and described as follows:

BEGINNING at an iron pin on the Northern side of Carey Street at the joint front corner of Lots Nos. 2 and 3, which pin is 100.8 feet west of the intersection of Chick Springs Road and Carey Street, and running thence with the line of Lot No. 2, N. 19-26 E. 106 feet to an iron pin; thence N. 71-45 W. 50 feet to an iron pin at the rear corner of Lot No. 4; thence with the line of Lot No. 4, S. 19-26 W. 105.6 feet to iron pin on Carey Street; thence with the Northern side of Carey Street, S. 71-34 E. 50 feet to the point of beginning.
