to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

R. E. Childress, his heirs and assigns

All those certain pieces, parcels or lots of land situate, lying and being on the southwest side of Crosby Circle in Gantt Township, Greenville County, South Carolina, being shown as Lots 150, 151, 152, 153 and 154 on plat of Paramount Park made by Piedmont Engineering Service, July 1949, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book W, Page 57, and having, according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Crosby Circle joint front corner of Lots 149 and 150 and running thence along line of Lot 149, S. 31-12 W. 154.2 feet to an iron pin; thence N. 50-30 W. 375 feet to an iron pin on the southeast side of Dorr Drive; thence along Dorr Drive, N. 40-00 E. 120 feet to an iron pin; thence following the curve of Dorr Drive (the chord being N. 84-36 E. 42.4 feet) to an iron pin on the southwest side of Crosby Circle; thence along Crosby Circle, S. 50-30 E. 260 feet to an iron pin; thence continuing with Crosby Circle, S. 52-55 E. 61.3 feet to the beginning corner.

This property is subject to the building restrictions which are fully set forth in deed made by W. O. Groce to W. D. Grant dated August 16, 1949, recorded in the R. M. C. Office for Greenville County, S. C. in Deed Book 389, Page 251, and the restrictions are hereby adopted, and made applicable to the lots herein conveyed.

The above described property is the same conveyed to the grantor herein by deed of W. O. Groce dated October 26, 1949 and of record in the R. M. C. Office for Greenville County in Deed Book 398, Page 39.

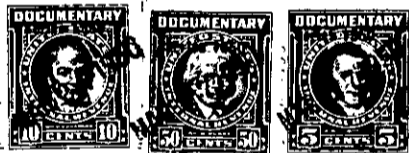
