Collinson and June W. Collinson, herein called grantees, all that lot of land located in the City of Greenville and lying in the southwestern corner of the intersection of Douglas Drive and Grenanda Avenue, and constituting the northern portion of lots 65 and 66, which lots are shown on a plat of Country Club Estates made by Dalton & Neves in October, 1946, and is recorded in Plat Book G at Pages 190-191, and from this plat the following description is taken:
