That This Conveyance, and all right, title and interest hereby conveyed in the
property above described, is, and at all times shall be, limited to a right of interment
only therein, and is subject at all times to the rules and regulations and by-laws of
said Corporation, on file in its office, now existing and/or which may be by it here-
after adopted either by amendment, alteration or the adoption of new ones, and
which are specifically referred to and herein inserted as if set forth in full; all of
