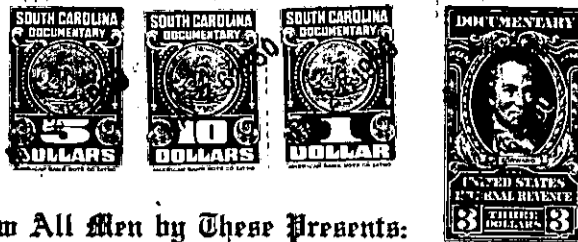

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James P. Moore and Otis P. Moore, their heirs and assigns forever:

*All that piece, parcel or lot of land in Greenville Township, Greenville County, State of S. C., known and designated as Lot No. 80 of subdivision of Eliza T. Looper lands, plat made by R. E. Dalton, and having the following metes and bounds:

BEGINNING on the north side of Wilson Street at the corner of Lot No. 79 which point is 150 feet east of the intersection of Keith Street with Wilson Street; thence with Wilson Street N. 71-20 E. 50 feet to corner of Lot No. 81; thence with Lot No. 81 N. 18-40 W. 160 feet to rear corner of Lot No. 99; thence with rear line of Lot No. 100 S. 71-20 W. 50 feet to rear corner of Lot No. 79; thence with Lot No. 79 S. 18-40 E. 160 feet to the beginning corner.

The above described property is identically the same conveyed to me by Eliza T. Looper on the 14th day of November, 1949, deed recorded in the R. M. C. Office for Greenville County, in Book 396, Page 109.

*ALSO, all that/certain lot in Greenville Township, Greenville County, State of S. C., known and designated as Lot No. 81 according to the plat of the land of Eliza T. Looper made by R. E. Dalton, December 1924, and revised July 1947, and having the following metes and bounds:

BEGINNING on the north side of Wilson Street 100 feet from the intersection of Looper Street at corner of Lot No. 82; thence with Lot No. 82 N. 18-40 W. 160 feet to rear corner of Lots Nos. 98 and 99; thence with the line of Lot No. 99 S. 71-20 W. 50 feet to rear corner of Lots Nos. 80 and 100; thence with Lot No. 80 S. 18-40 E. 160 feet to the north side of Wilson Street; thence with North side of Wilson Street N. 71-20 E. 50 feet to the beginning.
