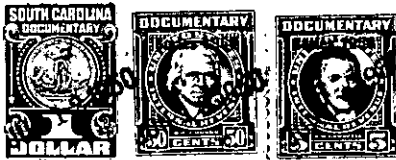

That We, O. Y. Brownlee and O. Y. Brownlee, Jr. in the State aforesaid, in consideration of the sum of Five Hundred and NO/100 (\$500.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Ronnie B. Woodall, his heirs and assigns forever:

All that lot of land in Greenville County, State of South Carolina, on the Southern side of Sycamore Drive, in the City of Greenville, and being the major portion of lot No. 106 and a small portion of lot No. 105, as shown on plat of East Lynne Addition, made by Dalton & Neves in May 1933, recorded in Plat Book H at Page 20, and according to a survey made by Piedmont Engineering Service on May 16, 1950, is described as follows:

BEGINNING at a stake on the Southern side of Sycamore Drive, 350.2 feet East from Lindsay Avenue, and running thence S. 20-40 W. 173.9 feet to a stake; thence S. 81-09 E. 45 feet to a stake at corner of lot 107; thence with the line of said lot, N. 26-57 E. 183.2 feet to a stake on Sycamore Drive; thence with the Southern side of Sycamore Drive, N. 86-45 W. 60 feet to the beginning corner.

Grantee is to pay 1950 taxes.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
