Know All Men by These Presents:

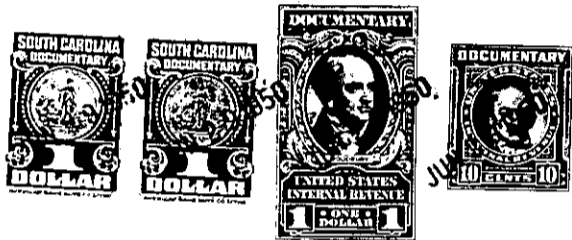
That L. F. Jones in consideration of the sum of Five Hundred Fifty and No/100 (\$550.00)----- in the State aforesaid, -----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James M. Bruce and Furman C. Smith, their heirs and assigns, all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, and being known and designated as Lot No. 35, as shown by survey of Dalton & Neves, Engineers, made April 1945, and marked Plat No. 2, property of W. S. Bradley. Said plat is of record in the R.L.C. Office for Greenville County, in Plat Book "O", at page 169, and according to said plat, have the following metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of Lee Road and running thence N. 1-50 E. 336 feet to a pin; thence S. 88-10 E. 138.8 feet to a pin; thence S. 0-42 E. 377.8 feet to a pin on the north side of Lee Road; thence with said Lee Road N. 73-0 E. 127.7 feet to the point of beginning.
