M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the Southeast corner of the intersection of Bradley Boulevard and Beverly Lane and running thence with South side of Bradley Boulevard N 52-26 E. 75 feet to an iron pin on the South side of Bradley Boulevard at the joint front corner of Lots Nos. 41 and 42; thence with the joint line of Lots Nos. 41 and 42 S. 37-34 E. 175 feet to an iron pin on the North side of a 20 foot alley; thence with the North side of said 20 foot alley S. 52-26 W 75 feet to an iron pin on the East side of Beverly Lane; thence with the East side of Beverly Lane N. 37-34 W 175 feet to the point of beginning.
