

KNOW ALL MEN BY THESE PRESENTS, That we, Fred Moore of Duncan, South Carolina; Leon Moore, of Spartanburg, South Carolina; Roy Moore of Belmont, North Carolina; W. A. Moore of Duncan, South Carolina; Mrs. Nell M. Mahaffey, of Duncan, South Carolina; Mrs. Mary Lou Moore Rothrock of High Point, North Carolina; O. M. Moore, Jr. of Baltimore, Maryland, and Mrs. Earline Moore Mayo, of Danville, Virginia, in consideration of the sum of TWO HUNDRED, SEVENTY-FIVE AND NO/100 (\$275.00) DOLLARS to us in hand paid at and before the sealing of these presents by W. A. Corbett and W. H. Corbett (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said W. A. Corbett and W. H. Corbett:

All that tract of land in Glassy Mountain Township, Greenville County, South Carolina, on both sides of South Pacolet River, and having the following metes and bounds according to a survey made by J. B. Livingston dated February 11, 1906, to-wit:

BEGINNING at a dead chestnut and running thence N. 12 E. 50 poles to a stake in field; thence due west 90 poles to a stake near rock; thence S. 13 W. 35 poles to an oak near the road; thence S. 50 E. 22 poles to an oak across creek; thence due east 53 poles to the beginning corner, containing 28 acres, more or less.

This property is the same conveyed to 0. M. Moore by James Gosnell October 30, 1913 by deed recorded in Book of Deeds 10 at Page 428.

This is a part of the same property conveyed by James Gosnell, Jr., to R. E. Johnson by deed recorded in Book of Deeds RRR at Page 530; the said R. E. Johnson conveyed the above tract to James Gosnell, Jr., by deed dated March 5, 1906, but was not recorded until January 22, 1914 in Book of Deeds 10 at Page 425, and meanwhile the said R. E. Johnson had included the said tract in his conveyance to Harvey A. Arnold by deed recorded in Book of Deeds PPP at Page 146, and this deed is executed to renounce any possible claim to the Grantor.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appretaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the said W. A. Corbett and W. H. Corbett, their Heirs and Assigns forever.
