PARCEL NO. 5 MADE UP OF TWO  
ADJOINING TRACTS AS FOLLOWS:

All that certain parcel or tract of land situated in Austin Township and State aforesaid containing forty-three and one half acres more or less known as Lot No. 2 in the plat-survey of lands of John Thomas Vaughan, Deceased and having the following metes and bounds to wit:

BEGINNING on a stone on Public Road and running thence N. 17 W. 12.22 to a stone; thence S.  $67\frac{1}{2}$  W. 1300 to a stone; thence S.  $4\frac{1}{2}$  W. 2975 to a stone; thence S. 88 E. 11.10 to a stone; thence N.  $16\frac{5}{8}$  E. 24.00 to stone on road the beginning corner bounded by lands Arthur Todd and Tract Nos. 1 and 3.

AND ALSO:

All that certain parcel or tract of land lying and being in Austin Township, County and State aforesaid, containing forty three and one-half acres ( $43\frac{1}{2}$ ), more or less, known as Lot No. 1 in the plat of survey of the lands of John Thomas Vaughan, Deceased, and having the following metes and bounds, to wit:

BEGINNING on a stone on Public Road and running thence S.  $16\frac{5}{8}$  W. 24 chains, to a stone; thence S. 88 E. 13.70 to double white oaks, thence N.  $4\frac{7}{8}$  E. 41.27 to a Post Oak; thence S.  $67\frac{1}{2}$  W. 15.00 to a stone; thence S. 17 E. 12.22 to the beginning corner, bounded by lands of F. C. Todd, G. B. Yeargin, James McKinney and tract No. 2.

Less however, eight acres, more or less, sold from the above boundary to Rich Morton leaving in said boundary 79 acres more or less.
