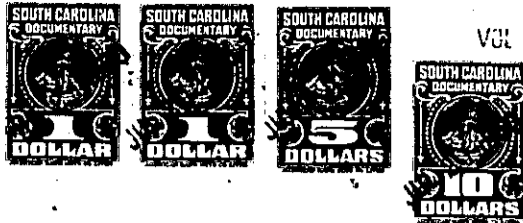

Know All Men by These Presents:

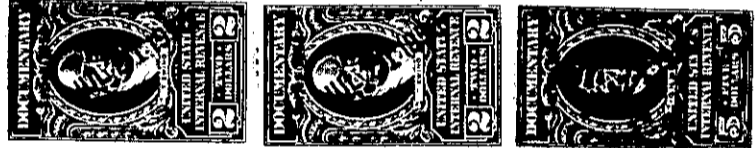

Griffin in consideration of the sum of Eighty Five Hundred and No/100 (\$8500.00) in the State aforesaid, to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Edrew H. Branyon and Roberta M. Branyon, their heirs and assigns, forever:

All that certain piece, parcel or lot of land with the buildings and improvements thereon situate, lying and being on the South side of Pleasant Ridge Avenue in that area recently annexed to the City of Greenville, in Greenville County, S. C., being shown as Lot 112 on Plat of Pleasant Valley, made by Dalton & Neves, Engineers, April 1946, revised through November 1948, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book "P", pages 92 and 93, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Pleasant Ridge Avenue at joint front corner of Lots 112 and 113, said pin being 90 feet West from the Southwest corner of the intersection of Pleasant Ridge Avenue and Panama Avenue and running thence with the line of Lot 113 S. 0-08 E. 160 feet to an iron pin; thence S. 89-52 W. 60 feet to an iron pin; thence with the line of Lot 111 N. 0-08 W. 160 feet to an iron pin on the South side of Pleasant Ridge Avenue; thence along the South side of Pleasant Ridge Avenue N. 89-52 E. 60 feet to the beginning corner.

This is the same property conveyed to me by deed of The Robert I. Woodside Company, dated March 2, 1950, and recorded in the R.M.C. Office for Greenville County, S. C., in Deed Book 404, page 155.

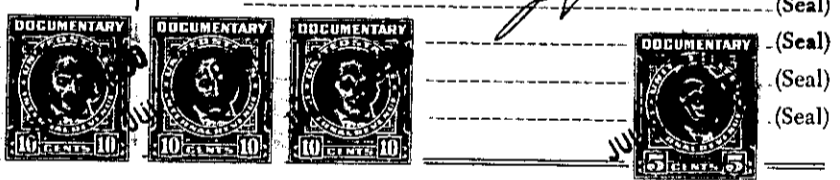
