Lindsey and Calvin G. Ridgeway, their heirs and assigns forever,

All that piece, parcel, or lot of land in the State and County aforesaid, in the City of Greenville, being designated as Lot No. 112, on plat of University Park by Dalton & Neves dated November, 1946, recorded in the R. M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Brookside Circle at the joint front corner of Lot Nos. 111 and 112 and running thence with the joint line of said Lots S37-34 E. 182.5 feet to an iron pin, joint rear corner of Lot Nos. 102, 103, 111 and 112; thence with the joint rear line of Lots Nos. 102 and 112, N52-26 E. 75 feet to an iron pin, joint rear corner of Lot Nos. 112 and 113; thence with the joint line of said lots N37-34 W. 182.5 feet to an iron pin on the Eastern side of Brookside Circle; thence with Brookside Circle S52-26 W. 75 feet to the point of beginning.
