KNOW ALL MEN BY THESE PRESENTS, That I, A. E. Holton in the State aforesaid, in consideration of the sum of TWO HUNDRED TWENTY-FIVE (\$225.00) and no/100 Dollars, to me in hand paid at and before the sealing of these presents by the grantee(s) hereinafter named (the receipt of which is hereby acknowledged), have granted, sold and released, and by these presents do grant, sell and release unto

R. F. LOOPER all that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina, being known and designated as Lots Sixty-One, (61), Sixty-Two, (62) and Sixty-Three (63) of SHERWOOD FOREST as shown on a plat thereof recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book Y, Page 23.

This deed is made subject to restrictions applicable to SHERWOOD FOREST and recorded in the R. M. C. Office for Greenville County, S. C., in deed Book 412, page 149, and further subject to utility easements of record.

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind himself and his heirs, Executors and Administrators to warrant and forever defend all and singular the said Premises unto the said Grantee(s) hereinabove named, and his heirs and assigns against himself and his heirs and assigns, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
