

Know All Men by These Presents:



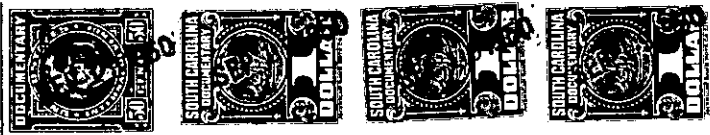

This conveyance is made subject to all conditions, restrictions and reservations contained in the deed of J. P. Stevens & Co., Inc., above referred to.

The mortgage herein assumed by the grantees was given by Bluford B. Fuller and Bessie G. Fuller to Liberty Life Insurance Company on March 1, 1949, in the original principal sum of \$3250.00 and is recorded in the R. M. C. Office for Greenville County in Mortgage Book 417, at page 297.
