Gregory that portion of lot #46 adjacent to lot #45 on Gallivan Avenue the same being one-half of lot #46 and beginning at an iron pin in the center of lot #46 facing Gallivan Avenue and running S19-17W 166.4 feet to an iron pin at the rear of lot #46 thence S34.53 feet to the corner of lot #45 and lot #46 thence along the joint lines of lots #45 and #46 167.8 feet to an iron pin on Gallivan Avenue and thence W34.5 feet to the beginning.
