All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and in Greenville Township, School District 8AB, and being known and designated as all of Lot No. 80 of a subdivision of the property of the Colonia Company, and a small portion of the 3.37 acre tract in the rear thereof and in the rear of Lot No. 79, as shown on plat thereof recorded in the R.
