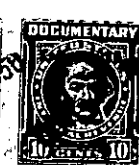
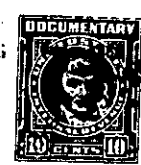
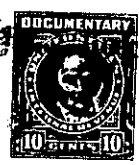

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Luther L. Vaughn, his heirs and assigns, all that piece, parcel or lot of land, situate, lying and being on the South Side of Potomac Avenue in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #242, Pleasant Valley, as per plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book P, page 93, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the South side of Potomac Avenue, joint front corner of Lots 242 and 243, which pin is 95 feet in a Westerly direction from an iron pin in the Southwest intersection of Potomac Avenue and Long Hill Street, running thence S. 0-08 E. 160 feet to an iron pin, joint rear corner of Lots 242 and 243; thence S. 89-52 W. 60 feet to an iron pin, joint rear corner of Lots 241 and 242; thence N. 0-08 W. 160 feet to an iron pin on the South side of Potomac Avenue; thence along the South side of Potomac Avenue N. 89-52 E. 60 feet to an iron pin, the point of beginning.

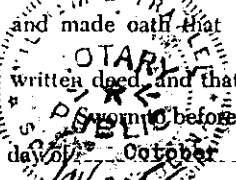
