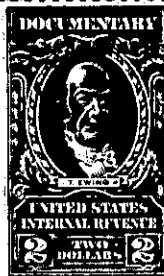

Heyward Barber and Elizabeth Barber all that piece, parcel or lot of land known as Lot No. 18, Section "B" of the subdivision known as Washington Heights as shown by plat made by N. O. McDowell, Jr. and Julian B. Moore, December, 1944. Said plat being recorded in the R. M. C. Office for Greenville County, South Carolina in plat book "M" at page 107.
