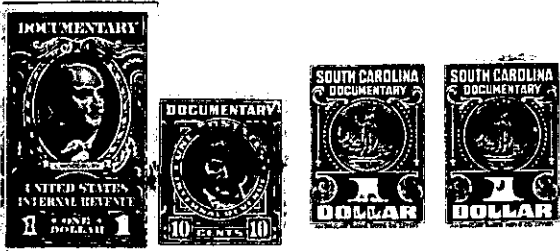
All that certain piece, parcel or lot of land situate, lying and being on the South side of Marshall Court, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot 81, on plat of Casa Loma Estates, made by Piedmont Engineering Service, in October 1947, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", at page 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the South side of Marshall Court, at joint front corner of Lots 80 and 81, and running thence with the line of Lot 80, S 24-02 E 163.6 feet to an iron pin; thence N 67-05 W 160 feet to an iron pin; thence with the line of Lot 82, N 14-27 E 98.8 feet to an iron pin on the South side of Marshall Court; thence along the South side of Marshall Court, following the curve thereof (the chord being S 87-59 E 64.7 feet) to the point of beginning.
